Dear Sir/Madam,

1. In pursuant to the comments/views received from RO's/Dy. RO's/Asst. RO's on conduct of online Annual Examination of Class-VIII and XI. The DAVCMC formulated guidelines to be followed for the conduct of Annual Examination of Class VIII and XI for the Academic Session 2020-2021.

Class VIII

- a) Annual Examination of Class VIII will be on the same pattern as given in Sample Paper or earlier years. The soft copy of Question Paper will be sent online on the day of Examination as per the datesheet.
- b) The examination will be of three hours. The paper will start and finish as per the timing laid-down in the date-sheet.
- c) RO's/Dy. RO's/Asst. RO's will have option either to hold online/offline examination in compliance to government orders prevailing in their state/area due to Pandemic situation in the country. The RO's/Dy. RO's/Asst. RO's are requested to send Online/Offline examination information to DAVCAE prior to the conduct of exam?
- d) For online Examination, the schools will sent the link of the Question Paper generated by school to the student.
- e) For online Examination students will be instructed to submit the answer sheet in PDF form within 20 minutes of completion of question paper. The soft copy of answer sheet will be sent to school on link provided to students. Students will not be asked to submit hard copy of answer sheet to school authorities if examination is held online.
- f) For online Examination strict invigilation will be carried-out by the invigilator detailed by the school for each examination. Students will be asked to keep camera on for the entire duration of examination.

Class XI

- a) RO's/Dy. RO's/Asst. RO's will make an endeavour to conduct offline examination of Class XI, however all the protocol as issued by Government will be totally followed during conduct of offline examination.
- b) The Question Paper will be sent a day prior/on the day of examination as per date-sheet.
- c) Principals will be asked to print hard copies of question paper as per the strength of children in each subject.
- d) The examination will be conducted strictly as per the timings and date given in the date-sheet.
- e) Proper invigilation including flying squad will be detailed by RO/Principal.

- 2. RO's/Dy. RO's/Asst. RO's will ensure fair and smooth conduct of examination of schools under their jurisdiction.
- 3. The above guidelines will be reviewed in second/third week of Feb., 2021 keeping in view the government instruction on opening of school/conduct of examination during Corona Pandemic. In case any fresh guideline issued by government, the amended directions will be issued by DAVCAE.
