#### **ADVISORY**

#### It may be very importantly noted that ....

- a. All clusters will send teachers as per the list. (List attached with the letter).
- b. Any change in the name beyond the list is not acceptable, if for any reason name is replaced, it has to be informed in written with a valid reason.
- c. No repetitive names from Level EEDP 1(LKG UKG) will be nominated for Level EEDP 2.
- d. Please ensure wherever more than one teacher is nominated from a cluster then both or all the teachers nominated should not be from the same school.
- e. MTs nominated should be **in sound health** and must provide a mandatory Certificate (including COVID TEST) duly filled and signed by participant to their cluster head before registering for the workshop.
- f. Mts who are suffering from any severe medical ailment must not be nominated.
- g. MTs must provide an additional contact number who could be contacted in case of any medical emergency.
- h. MTs who can easily travel individually (no relatives/family members are allowed) are eligible for the Program.
- i. Since it is a residential program wherein participants are expected to complete the previous day assignments/work so it is advised to follow the protocols of laying emphasis on learning aspect rather being a vacationer.
